

Report of The President

On May 9, 1939, at the request of the Chamber of Commerce a group of interested people met at the Hawthorne Building, Berryville, to consider the formation of a county historical association. During the past few years interest in the history of the county had been steadily increasing, due particularly to the exhibitions held at Greenway Court in 1932 and at the Berryville High School in connection with the Centennial celebration of 1936. An organization meeting was held on May 19, a charter and by-laws were adopted and officers elected on May 31, and after meetings on June 16, July 7, and August 7 outlining the work to be undertaken, a membership drive was launched on August 28th. It was decided to concentrate the efforts of the Association in the first instance on the preservation of existing material of historic interest and more specifically to list and photograph the early buildings and portraits, to transcribe the inscriptions on the tombstones in family graveyards, to discover original documents, letters and records in private hands and to set down the personal recollections and traditions of the county's history. Through the courtesy and cooperation of the Board of Supervisors and the County Clerk, the Association received permission to place in the vault of the Court House sets of shelves and a fireproof and burglarproof safe to house objects of historical interest given or lent.

The response to this program was most gratifying not only in the number of members gained by the Association but particularly in the effort expended in carrying it into effect. During the first year 123 people became members of the society of which 97 are regular members, 2 life members, 2 sustaining members, and 22 contributing members. 54 members live outside the county. This is a most encouraging beginning and one which we hope can be sustained and increased during the future.

The reports of the various committees indicate the results obtained. The collection of negatives of portraits is already one of the best in the state and before long should be one of the best in the country. The Archives Committee has collected a complete file of the Clarke Courier since its first issue in 1869, thus making available an invaluable source of county history. At its monthly meetings the Association has been addressed by Mr. Thomas T. Waterman of Williamsburg, Mr. Vernon Eddy and Mr. Floyd Flickinger of Winchester, Professor Lester J. Cappon, Archivist of the University of Virginia, Mr. J. L. Dickinson of Front Royal and Mr. W. F. Alexander of Charles Town, West Virginia. One of the most interesting and significant meetings was that at which were exhibited the models

of early buildings made by the rural school children of the county. Three historical tours to twelve of the early houses in the county have been made and joint meetings have been held with the congregations of old Bethel Church and the Jefferson County (W. Va.) Historical Society. The Hutton Collection of engraved portraits of 18th century English race horses has also been exhibited and through the courtesy of the Misses Beatty the collection of photographs of portraits was shown for several days at The Black Penny in Millwood. The Clarke Courier has at all times been most generous in its interest and support.

Although much has been done still more remains undone. We need funds to photograph carefully and thoroughly the early buildings in the county and to complete the work of the portrait committee. We should photostat many of the original documents now in private hands so that these records may be forever preserved. The restoration of Greenway Court could be made as significant a monument to the Virginia frontier as Williamsburg is to Colonial Tidewater. In the not far distant future the space in the county vault will become too limited for the Association's constantly growing collections. We hope that we can count on the continuing and increasing support of the members to carry on our work.

Report of The Portraits Committee For 1940

TO THE CLARKE COUNTY HISTORICAL ASSOCIATION:

The actual work of making a collection of photographs and negatives of Clarke County Portraits was begun in April. By the close of the year the following results had been attained:

Through the last half of 1939 and the first quarter of 1940 the Committee was engaged in disposing of the following necessary preliminary work:

- 1. A determination of the scope of the collection.
- 2. Cataloging portraits now in Clarke.
- 3. Discovery and listing of eligible portraits not now in the county.
- Decision upon a mass of technical detail regarding photographic work; type and quality of equipment for the mounting, and care of prints; and the care and preservation of negatives.
- Determination of the kind, character, and quantity of data—biographical, genealogical, and historical, for each portrait photograph.
- Selection of the best available portrait photographer and the execution of a contract with him.

For the purpose of cataloging portraits now in the county three District Chairmen were appointed: Miss Rose MacDonald for Longmarsh and Battletown; Mr. E. G. Butler for Chapel; and the Rev. Mr. Rowland for Greenway; and, simultaneously, through extensive correspondence and by other methods preparation of a list of other portraits was carried on. A fairly comprehensive catalog of portraits in the county together with a small listing of other eligible portraits was ready by the late summer of 1939. Type-written copies of this Catalog of Clarke Co. Portraits were sent the Frick Art Reference Library and Dr. J. Hall Pleasants, the nationally known Baltimore art expert and collector, for their inspection. The Frick Library was sufficiently interested to have a copy of the catalog typed

for its files and to select 32 of the portraits listed for inclusion in the Frick Collection. Throughout 1940 additional listings for both sections have been discovered and at some subsequent date a revised and enlarged catalog should be issued.

By January the Committee was able to turn its attention to solution of the technical questions involved and its decisions in these matters were largely guided by the advice and suggestions given it by Miss Ethelwyn Manning, librarian of the Frick Library, and Dr. Pleasants. Grateful acknowledgement is made to both for their most valuable assistance and the amazing amount of trouble they have taken to be helpful.

The vital importance of first class portrait photographic work was fully realized by the Committee. Various photographers were asked to submit samples of their work in portrait photography. These samples were sent on to experts in the Frick Library for critical opinion, the quality of the workmanship being the determining factor in awarding the contract. As the result, Mr. C. Fred Barr was awarded the contract. By guaranteeing him a large volume of work more favorable financial terms were obtained than would otherwise have been possible. Mr. Barr's portrait photography has been praised by experts.

By mid-April the work of making the collection was in full swing and so was the work of collecting and preparing the historical, biographical and genealogical data for the portrait photographs. Brief and limited as this material both through necessity and choice must be, it involved extensive correspondence and a large amount of research. Assistance was sought from, and in a number of instances given by portrait owners. The Chairman of the Portraits Committee to whom fell this phase of the work wishes to acknowledge also his indebtedness in this connection to Dr. Pleasants, the Handley Library, and Miss Mary F. Page of "Saratoga".

As the year progressed and as the work went on, it became apparent that the portrait owners in Clarke County were giving the Collection generous support and so were others outside the county. This support is best evidenced by the fact that of the 171 negatives in the collection, 142 were donated and only 29 had to be bought. In addition checks to assist in carrying on the work were received from Mrs. Spencer Carter, Mr. Kenneth N. Gfipin, Mr. George P. Greenhalgh, and an anonymous giver. The net result of all of this has been that although a very considerable sum of money was necessarily expended by the Portraits Committee in 1940, the appropriation made to it by the Clarke County Historical Association at the first of the year remained intact at the close of the year, assuming that unpaid bills receivable are paid. Because of the essential importance of this subject the Committee feels that it should state unequivocally that the collection it is making for this Association is far beyond the means of the Association to finance from income. Such a collection is an expensive undertaking. The results obtained in 1940 were possible only through the generous financial support of the portrait owners of Clarke County and non-resident friends of the Collection. Further growth is mainly dependent upon continuation of their support.

The difficulties experienced in obtaining prints of many eligible portraits has afforded convincing proof of the very real need of a source from which photographs of Virginia portraits and especially of historical Virginia Portraits can be obtained on reasonable terms. It is true that the Frick Library and some other collections own negatives of a number of Virginia portraits. But it is a fact, as true as it is regrettable, that only commercial photographers own negatives of an amazingly large number of Virginia's most interesting and most historic portraits, many of which are eligible for the Clarke County collection. These photographers apparently charge for prints whatever they think they can get, nor can the purchaser feel certain that he gets what he pays for excessively.

The Portraits Committee is convinced that the most valuable service the Collection can make to the public in general and Virginians in particular is to supply prints to those who may desire them and on a non-profit, non-commercial basis, from any negative owned by the collection. This service it now offers the public, the only requirement being that orders for prints, filled the first and middle of each month, must be accompanied by the written consent of the owners of the portraits. It is to render such a service that the Committee has made every effort to obtain negatives of portraits represented in the collection and will so continue.

The total of fine and historic portraits eligible for this collection and having an interest extending far beyond the County's boundaries, is amazingly large. The number of portraits now in the county and having a more local interest is also surprisingly large. These facts have made it possible after only seven months of active operation to make the Clarke Collection one which would undoubtedly be a welcome and valuable addition to any collection in the State.

The scope of the collection as determined embraces these three classifications: 1. All portraits at present in Clarke; 2. All portraits which were once in the county but are no longer here; 3. All other portraits which in the judgment of the Committee are sufficiently identified with Clarke to make their inclusion appropriate—such as portraits of persons who were born in the county or who lived here for a number of years or who owned Clarke land—even though the portraits themselves were never in the county physically.

If the scope of the Collection should be extended to include portraits of ancestors of the present residents of the County the Clarke County Collection could in time be made the outstanding collection of its kind in the State of Virginia and a collection of National importance as regards Virginia portraiters. The Committee realizes that this would be a difficult and expensive undertaking. It does not feel it is either an impossible or impractical one, over the years.

In concluding this report the Portraits Committee wishes to express its appreciation to The Winchester Evening Star and especially to the Clarke Courier for the interest these two newspapers have taken in its work, which interest, it feels, has been most helpful to that work.

Report of The Archives Committee

The Archives Committee feels that the first full year of its operation has been a successful. It has received gifts of some fifty titles—books, pamphlets, maps. It has received promises of the presentation of a large number of other titles, some of exceptional interest and very real historical value. This Committee has been handicapped in its work by a lack of suitable facilities for the best care and preservation of the material entrusted to it. It believes that when such facilities become available the growth of the Association's archives will receive a new impetus and acceleration both as to volume and quality.

A substantial beginning has been made, however, in the celebration of books and pamphlets dealing with Clarke County and its people, and in the collecting of works of Clarke writers.

The Clarke County Historical Association is indebted to Dr. John W. Wayland, that distinguished historian of the Shenandoah Valley, for his gift to it of five volumes written by him.

The Association is indebted to Mrs. R. S. Bryarly for the gift of "A Topographical Description of the Counties of Frederick (which then included Clarke), Berkeley and Jefferson" by Charles Varle. This rare and valuable work was published by W. Heiskell, Winchester, Va., in 1810. It is indebted to Mr. Stuart W. Jackson for the negative of a map of what is now Clarke which was made in 1820. The map itself is in the Library of Congress. The Association is indebted to Mrs. Courtney Byrd Jones for autographed copies of "Canolles: the Fortunes of a Partisan of '81", "Fairfax, the Master of Greenway Court" and "Hilt to Hilt"—all by John Esten Cooke.

Among the works the Association now owns dealing with Clarke County may be mentioned: "Old Chapel", by Miss Mary F. Page and Mrs. Edward Gay Butler; "An Historical Sketch of the Old Chapel" by Captain William N. Nelson, and Thomas D. Gold's "History of Clarke County."

OLD BUCKMARSH CHURCHYARD

RUSSELL GRAVEYARD

The grave of Virginia Mc-Cormick in this graveyard was marked with a stone somewhat like a picture frame, resting on a pedestal, with her picture sealed therein. PRIVATE GRAVEYARD ON "PRIMROSE" FARM



PRELIMINARY LIST OF EARLY HOUSES IN CLARKE COUNTY

"SHERWOOD" in Warren County, just over the line from Clarke, was built in 1839 by Richard Harfield Timberlake. The estate is part of the Davis tract and is now the property of Harvey M. Schaeffer, who bought it in 1940 from Mrs. John A. Thompson. The house is of brick, a three story structure, L shaped, and contains ten rooms.

"MT. ZION", at Milldale, is part of the Borden tract of 1734. In 1771 it was purchased from William Denny of Pennsylvania by the Rev. Chas. Mynn Thruston of Gloucester County, who built the present house and gave it its name. The house is one of the earliest of architectural interest in the Lower Valley and it is believed that the handsome woodwork was carved by Hessian Prisoners interned at Winchester. In 1841, the property was purchased by Colonel John B. Earle and is now owned by a grandson of the same name.

"GUILFORD", near Stone Bridge and owned by Mrs. George Lee, was built prior to 1820 by James Madison Hite, son of Major Isaac Hite of "Belle Grove". The house is plastered and has large white columns at the front. The hall and stairway are said to resemble those at "Carter's Grove" in lower Virginia.

"FARNLEY", part of the Borden Tract, now the property of Mr. A. Mackay Smith, was built in 1832 by Dr. James Hay, who married Eliza Gwynn Burwell of "Carter Hall". It is of interest that the beautiful woodwork and mantels are in many respects identical with those at "Tuleyries", which was commenced in 1828.

"GREENWAY COURT" was the seat of Lord Fairfax, and while the original house was pulled down many years ago, the old estate office and powder house still stand. The house in which his Lordship resided was built about 1752. The old stone office building is of great interest as from it titles to hundreds of thousands of acres in this part of the State were issued. The property, near White Post, is now owned by the Kennerly family.

"PAGEBROOK", owned by Mrs. Phillip Walker, is of stone, plastered over. The walls are 27 inches thick. It was built in 1784 by John Page of Hanover County who married Maria Byrd of "Westover". The place remained in the Page family until 1900. It was part of a grant from Lord Fairfax dated 1730 to "eight gentlemen from Tidewater".

"CLAY HILL" was built by Francis Beverley Whiting in 1816 on land owned by his wife, Mary Burwell, daughter of Col. Nathaniel Burwell of "Carter Hall". It is now the property of Capt. Ewart Johnston. During the Civil War the place was a favorite stopping place for Col. Mosby.

"FAIRFIELD", at Gaylord, is part of a grant given by Lord Fairfax to his cousin, George Washington Fairfax, in 1774, the original deed being in the possession of the present owner, Mrs. John D. Richardson. Warner Washington, who married Hannah Fairfax, bought the estate from his brother-in-law, and immediately began the erection of the dwelling, of blue

limestone quarried on the place. It later passed into the hands of the eldest son, Fairfax Washington, who sold it to William Byrd Page in 1809. In 1830 it was bought by John Richardson, and has remained in the family since that time. "Fairfield" is also known for its lovely gardens and old box wood.

"MILTON YALLEY" on the Millwood pike, south of Berryville, was built soon after the marriage of John Milton and Anne Stribling, on July 20, 1872, by Mr. Milton. In 1818 it became the property of Capt. William Taylor, who married a daughter of John Milton. The late Frank V. Tilford restored the property about 1925.

"CARTER HALL", at Millwood, owned by Mr. Gerard B. Lambert, who purchased it a few years ago from Mr. J. Townsend Burwell, was completed in 1790 by Col. Nathaniel Burwell who came to the Valley from "Carter's Grove", near Williamsburg. The main building is sixty-six feet by thirty and three stories high, with a two-story wing at each end, twenty one feet long. It is built of stone covered with plaster. Many distinguished guests have been entertained at "Carter Hall". Edmund Randolph, first attorney general of the United States died while visiting here.

"COOL SPRING" was built prior to 1799 by William Wormley, son of Ralph Wormley. It lies on the west bank of the Shenandoah, several miles north of Castleman's Ferry, and is now the property of Mr. Alden Cummins. Several of the window panes in the house bear the following inscriptions: "Susan Wormley and Captain Richard Kendall, London, 1799", and on the same pane a small island is scratched with "May peace and plenty bless our isle", written around it. On another glass is the inscription, "The beautiful Annana Wormley went to Winchester tonight to dance with handsome Tom Marshall, December 1799." The house is built of stone with a large center hall and a paneled room on each side.

"SARATOGA", home of Misses Mary and Agnes Page at Boyce was built in 1781 by General Daniel Morgan. The work was done by Hessian prisoners who were under his care, and as the "Old Thunderbolt" believed not in idle hands, he caused several buildings to be erected by these men. The stone used in "Saratoga" is reported to have been carried from the Opequon. General Morgan named his home for the famous battle by that name.

"CLERMONT" is a quaint house on the River pike, just east of Berryville and was the pre-Revolutionary home of the Snickers family, who were large land owners at that time. It was a frequent stopping place for Washington. The property is now owned by the family of the late Admiral Dupuy McCormick.

"FOUNTAIN HEAD", built in 1795 by the Stone family, of logs and stone. The barn is said to bear the date 1798. For many years the place was known as Stone's Tavern, being on the road traveled by teams hauling to Baltimore, now called the old Charles Town-Winchester pike. There is a large spring in the yard which tradition says used to furnish water for as many as fifty carts a day. "Fountain Head" was owned by the Pierce family until a few years ago.

"HELMLEY", a picturesque house of stone, said to be the oldest stone house in Clarke County. It was the house of Meredith Helm, one of the

first Justices of Frederick County. Through the marriage of his grand-daughter, Jane Helm to Fielding Calmes, the place came into the Calmes family about 1786. "Helmey" lies on the Opequon Creek.

"LONG BRANCH", in the White Post neighborhood, is the home of Mrs. Hugh Nelson. It is of brick construction and particularly noted for its beautiful spiral stairway. The house was built in 1805 by Robert Burwell. Since then it has always been owned by descendants of Governor Nelson.

"THE RETREAT", on the east bank of the Shenandoah River, about a mile north of Castleman's Ferry, was originally a 1200 acre tract, the home of General Thomas Parker, officer in the Revolutionary war and in the war of 1812. Later was property of Judge Parker. Is now owned by Mr. Leeds Riely.

"MOUNTAIN VIEW", near White Post, was the home of Bishop Meade. It was part of the "Lucky Hit" estate upon which his father, Col. Richard Kidder Meade, Aide de Camp to General Washington, settled after the Revolutionary war. The house was built in 1810, the Bishop and several hands burning the brick used in its construction. Now the property of L. T. Larrick.

"TULEYRIES", was built in 1828 by Col. Joseph Tuley, who came to this section from New Jersey. Col. Tuley was regarded as a very wealthy man of that day and "Tuleyries", with the handsome mansion and the park in which he kept elk and deer, was one of the show places of the county.

"ANNEFIELD", south-west of Berryville, the home of Mr. and Mrs. William Bell Watkins, was built in 1799 by Matthew Page, and named for his wife, a daughter of Colonel Richard Kidder Meade. The house is of blue limestone, the woodwork of the rooms being handsomely carved.

"BLOOMFIELD" lies north-west of Berryville and is the property of Mr. H. E. Boyer. It was built in 1775 by Jacob LaRue, and this date and his wife's name, "Mary", are in a gable of the stone house.

"OLD CHAPEL" is the oldest Episcopal church west of the Blue Ridge, having been erected in 1790 on land given by Col. Nathaniel Burwell. This building replaced an earlier one of logs, which stood a few feet south of the present structure. Bishop Meade was minister at the Old Chapel for 25 years. The interior of the building is of great interest, the high pulpit and the narrow straight-backed pews; the velvet bags on long handles for taking up the alms. The building is used once a year for services, and occasionally for the last rites for some descendant of those whose mortal remains already rest under the shade of the old trees in the Old Chapel yard.

"SMITHFIELD", attractive brick house at Wickliffe was built by Edward Jaquelin Smith in 1835 or 40, to replace a house of logs. The brick were burned on the place for its construction as well as for the two four room houses on either side of the mansion house, the barn and slave quarters. A stream runs through the yard in front of the house adding to its pleasing setting. Mr. Smith also had the brick for the Wickliffe Church burned on his place.



Extracts From The Above

TO THE PUBLIC

It is with diffidence I present to view this Topographical Description of the Counties of Frederick, Berkeley and Jefferson—confident, that, from my being unaccustomed to commit my ideas to paper, in the English language, a number of errors, in point of diction, have been committed—a truth of which, the reader will doubtless soon be convinced. The task, from the reason given, has been an arduous one, but the motive was imperious. The public good was my object. In the publication of this work, I have anticipated the wishes of many of the farmers in the counties spoken of, who contemplate emigrating to the Western country; as it is obvious, that

the circulation of it, will afford, to those disposed to purchase property in those counties, some data, whereby to estimate its value, and consequently enable those disposed to sell, to obtain the real value for their property. The desire of many of the people of the neighboring counties of Maryland and Pennsylvania, to leave a soil, which has advanced in value, beyond the reach of a moderate capital, has also impelled me to the publication of this little work, which, although not decorated in the elegance or correctness of language of a Buffon or a Goldsmith, may be relied on as a faithful description of the three counties of which it treats—and, I flatter myself, that the interest of both the buyer and seller will be promoted by the plan I have Independent of the considerations already mentioned, it is obvious that many other advantages will result-the intercourse with other states will probably be increased, which will doubtless produce a circulation of money, an increase of population, and consequently of industry, and the various advantages attendant on those circumstances. Besides, it will contribute, I hope, to facilitate improvements in those counties, as turnpike roads, canals, erecting manufactories, &c. redounding to the benefit of individuals and the state at large.

Situation and Boundaries

of THE COUNTY OF FREDERICK

The County of Frederick, is situated in the state of Virginia; it is 28 miles in its greatest length, and 20 in its greatest breadth; it is bounded to the North, inclining to East by the counties of Berkeley and Jefferson; to East, inclining to South, by the county of Fauquier, having for its line of division the summit of the South Mountain, called also the Blue-Ridge, and the county of Shenandoah, the Cedar Creek running between the two; to the South, inclining to West, by the said county of Shenandoah, having in part a straight line for boundary, coming afterwards in contact with the river Shenandoah, and running with the said river until it comes to the junction of Cedar Creek and the latter river; then, with said creek as far as the bend of it, then striking nearly West by a line, and after having crossed Paddy's Mountain, comes in contact with Hardy county; to the West inclining to the North with the said Hardy and Hampshire counties.

CONTENTS

The surface of this county contains 735 square miles, which, at the rate of 640 acres to each square mile, gives a superficies of 470,400 acres.

POPULATION

The article of the Population of Frederick county in 1800, as extracted from the official documents, should read thus:—

Total 24.513

Making 34 souls to each square mile; and, snowld the enumeration of 1790 that has been obtained from information be correct, there would be an increase of 3,038 souls in the population of this county since that period.

PRODUCTIONS

It is well known that the 39th degree of latitude is one of the mildest climates on the globe, being nearly equi-distant between the torrid and the frigid zones; consequently one of those happy climes so much vaunted for temperature and health, and partaking of the same advantages with the beautiful and renowned countries of Italy, Spain and Portugal, where the grapes, olives, almonds and other lucious fruits abound. If this soil does not afford those rich productions now, it is because the climate in winter is too cold, but it will become no doubt milder in proportion as they will clear the surface of the ground; at present its productions are chiefly in grains, viz: wheat, rye, Indian corn, oats, barley, &c. a very small quantity of tobacco is raised here. The wheat is ground into flour by the different merchant and grist mills, is packed up in barrels, and sent by wagons and boats to the different seaports; the other grains are used chiefly on the spot Part of the rye and Indian corn are distilled into whiskey and gin, and partly sent to market, &c.

The fruits raised here are apples, peaches, pears, cherries, &c. The two first are ranked among the number of luxuries, as well as of profit, in the county, in being distilled, partly into brandy. Vine-yards, in my opinion, would succeed better here than in Washington county, Maryland, (where they have of late planted the European vine with success, and made wine,) on account of the latitude of this county being more Southerly.

NATURAL CURIOSITIES

There are two caves in this county; one near Zanes' Old Furnace, under the north mountain, a description of which, I think useless, since it has been described so often in different works, particularly by Mr. Thomas Jefferson in his notes on Virginia.

The other lies near Cedar creek on Buffaloe Marsh.

There is also a natural well, said to be unfathomable, on the land of Mr. Laurence Lewis, near Shenandoah river: these caves and wells are found commonly under the surface of limestone land.

MILLS

I have counted 75 merchant or grist mills in this county; as many saw mills; several oil mills; one paper mill; seven fulling mills, and one tilt hammer.

RIVERS AND PRINCIPAL CREEKS

Only one river passes through this county, and this is not navigable at all seasons of the year; though a company have been engaged in the improvement of its navigation. It would be better, in my opinion, to swell the waters by means of stone dams across the rivers, which would cause a considerable depth at once, and a lock being set on the side of each, (and on the banks, if possible, in order to put it out of the reach of the ice,) would render the navigation permanent, and good at all seasons. This would not be an additional expense to the company, nor to interested individuals, because the sale of the mill seats on such a never failing water, would pay for it.

The principal Creeks are Opiquon, Back and Sleepy Creeks, none of which are navigable; but Opiquon could easily be made so by the above means.

QUALITY OF THE SOIL

In order to give an idea of the true quality of the soil in this county, it is proper to divide it into parcels and valleys.

First—All that parcel along the Blue Ridge mountain—the soil of which is mountainous; appears to be of a good quality, and fine farms are seen on it, and although valuable at this present time, they will become more so, in proportion as care and attention will be paid to their cultivation.

Second—This is another slip of land, about 6 miles in breadth, and joining the above parcel, which includes Front Royal, White Post, Stoney Point, Millwood, and Berryville. This tract is of a very superior quality of limestone land.

Third—This slip of land is higher situated than the above and joins it, its quality is slate; the plaister of Paris works miracles on this soil.

Fourth—This parcel runs along the Little North Mountain, and includes Middletown, Stephensburg and Winchester; it is a strong lime-stone land, excellent for the production of all kinds of grain.

Fifth—This is a valley between the Little North Mountain and Paddy's and North Mountain. The land immediately under Paddy's and North Mountains, are partly lime-stone; Pughtown is included in it. The remainder of it is slate, which, in my opinion, will become valuable in proportion as the spirit of improvement shall animate the farmer.

Sixth—This tract is the most Westerly of the county; it is hilly and broken. The best lands here, are situated on the bottoms, along the creeks; some parts of it afford good crops of small grain, and would, no doubt, be highly improved by the plaister of Paris.

BERRYVILLE, (BATTLETOWN)

Lies 11 miles 1/8 from Winchester, on a very fertile and well improved lime-stone soil: it contains upwards of 25 dwelling houses, 3 large stores, 1 apothecary shop, 2 taverns, and a number of mechanics. 4 physicians make their residence in this place: an academy is kept here, to teach all the liberal branches of education and mathematics, in a well appropriated stone building.

MILLWOOD

Contains from 50 to 60 souls. Here is a large merchant mill, an fine extensive manufactory of leather, one tavern, a large store, a blacksmith, a taylor, a boot and shoe make, and a waggonmaker. It is 12 miles and ½ from Winchester, on a rich limestone soil.

WHITE POST

Contains one store, a tavern, a saddler, a shoemaker, a blacksmith, and a wheel-wright. This place is situated 12 miles from Winchester, on a rich and beautiful limestone soil.

STONEY POINT, (Known today as Ninevah)

Lies on a rich lime-stone country; it contains a store and a few houses; 12½ miles from Winchester, on the road from that place to Front Royal. All these last towns, though small, are of great service to the wearied traveller, for supplying him with refreshments.

Recollections of Old Wickliffe Church

A Sunday morning service in the Summer of 1829.

We have just stepped out of the carriage at the door of this old church now surrounded by a forest. My aunt and sisters, Sara Jane and Elizabeth. We enter. I, a little boy come, following, my aunt. We take our seats near the pulpit. I look around; the building is not large the to me, the ceiling is very high. The walls white and bare looking, save here and there. where smoke and cobwebs have discolored them. There are no pews; but hard benches with a strip of plank for backs instead. A gallery along its front for servants; the pulpit somewhat in shape after a fashion of the S. Grove "lyehopper"; the floor so uneven that I stumble over it and am confused lest some one notice me. There is no paint on any of the wood work. An old ten-plate stove stands in the center of the building, from which a long rusty pipe wabbles its way to the wall, looking seedy and drunk, while the stove itself looks dead and cold tho it is midsummer. In winter more smoke comes from the disjointed pipe than from the stove itself.

Well, here I am between my aunt and sisters. The ladies of the congregation occupy seats in the upper half, while the gentlemen the lower half of the church. The small boys sit with their mothers, the large boys with their fathers. I wish I were a large boy. They come to church on horseback, and are not cooped in a carriage, "where you don't see nothing".

In front and around me are the Williams, the Allens, (Mrs. A. wears a white turban, has a fresh rosy complexion; I think her beautiful) the Smiths, the Opies, Shiveleys, Castlemans, and of late, the Parkers, refined looking people. Mrs. Lewis of the Rocks, sits just in front with two or three freckled faced sons, and a sweet faced looking little daughter, who, when grown, was charming in manner, and lovely in character. She was thrown from a carriage, the horses of which, were running away, and died from the injury.

I never can forget the scene at her burial, in the old family grave-yard, a secluded spot, "The Moorings". It was a sweet October evening, the fields, the forests and mountains glowing with the tints of autumn. And as the sun sank to rest, the shadows of night fell upon the landscape; so as her bright, sunny life was laid to rest, shadows dark fell upon all hearts. There stood her eight brothers—she was an only sister—who had delighted to honor her with a deference and courtesy worthy of loves, the tears silently trickling down their manly cheeks. The neighborhood was shrouded in sorrow, that was never lifted from the heart of her aged mother, who ere long was placed by her side. Mary Lewis, your sweet spirit burst into a glorious Angel at the gates of Paradise.

But I ramble. While the service proceeds (the clergyman, the Rev. Alexander Jones, a large handsome man, with black hair and eyes and a

ruddy complexion), I look especially, when we kneel down, at the gentlemen of the congregation, fathers and sons. They don't kneel like us; most of them stand up, turn their backs, and rest one foot upon the bench, but look solemn and decorous. Just in the rear of me, and next to the dividing line of sexes, sit Betsy and Polly Kerfater, mother and daughter. The servants tell me, Polly "ain't got good sense". Betsy and Polly are white servants of a near neighbor (Miss Jane McPherson) and as they are the only ones I have seen, infer that they are all that are in the world. Betsy turns her back, and puts her foot on the bench, too, like the gentlemen: I notice Mr. Jaquelin Smith particularly. He is a grave stern looking man. I hear he never kisses his children.

I have been told that the Spring Grove house is a hundred years old; I infer that all houses that old must have been made when God made the world. With this impression, I went to Mr. Smith's with my aunt on a visit, and there I saw he was actually engaged in building a house, the walls of which were about three feet high. I was struck dumb with astonishment, and was so impressed with this awful exhibition of his power, that some of still lingers.

To return: the service over; the sermon begins. Gracious, what a desert it is to me this hot day. One long, dull monotonous sound, I lean my head against the strip of wood but it hurts. I sit up, look about, and That boy over there with his head against the wall, and mouth open, fast asleep, ought to be ashamed of himself; everybody sees him. There is another boy puffing his jaws out and skinning his eyes. And another got his feet on the seat playing with his toes. I bet I can outrun any of them. Sam says I can whip any boy that comes to church here. Once when Jackson, a negro boy, and I had a fight behind the dining room chimney, without my aunt's knowledge tho, the result of which I thought at least doubtful, Sam assured me I was victor, as I cut, as he said, a "pocket flap" over Jackson's eye, and bumped it too; but he did not know how my ribs hurt. Well, to continue. I get the figits in my feet. so tired and hot, and grow desperate. I see a dog looking inquiringly in at the side door, his head on one side and ears slightly raised; he makes a move to enter, is met by a whip in the hands of a gentleman, and suddenly changes his mind. I don't know what on earth he wants to come in here The sermon goes on until unexpectedly I hear the words, "If I take the wings of the Morning, and dwell in the uttermost parts of the Sea, then shall thy hand lead me, and thy right hand hold me." I start and whisper to my aunt, "I know that." She is pleased and tells me so when we get Then the dull, unintelligible sound is resumed, broken now and then by the stamping of the horses outside. I see an old man and son, both in very linsey woolsy clothes, old Mr. Dick and son; they live in the mountains, I am told, and walk here. What is most strange, I see them at the Old Chapel, too. How do they get to both places, I speculate? how I do, but how do they? I wonder about this until I cease to think, and am startled by a sudden jerk, and find I narrowly escaped a fall. The sermon at last over. It's been going on a month. Mr. Jones comes down, after some ceremony of which I do not remember to have witnessed before, the ladies go forward and kneel at the chancel. Aunt B. goes, and I attempt to follow, when I am checked by sister E., with a suppressed laugh. I am conscious I have done something ridiculous, and blush until the roots of my hair seem scorched.

She perhaps sees my mortification, as she makes no allusion to it afterwards; sweet of her. Church out, we get into the carriage; brother Richard and John, youths then, are on horseback, with long, limber, yellow, willow switches in their hands, part of the way accompanied by John Taylor, Hiram Opie, the elder Lewises, Sidney Allen, William and George Turner and Wormley and Milton Norris. Oh, if I were big enough to ride on horseback, too.

This is an old postillion carriage, being large, to which, I am told, in my grandfather Sinclair's day, four horses were attached for distant journeys. Now, but two are used. Jack is driver, and rides the left horse. Sam is footman and informs me the drivers of other carriages laugh at this. He further says confidentially, "da needn't to laf, case our people rid in carriages fore dem was born." I am comforted.

I often stretch out full length on the front seat and am lulled to sleep by its drowsy creaking and easy motion. We see Clifton off on the horizon to the west, then Smithfield, then Waverly, the Howards, McPherson's Mill, and at last home again. When I go to church, why is Sunday so long? From breakfast to dinner seems as long as from Christmas to Christmas.

I see you still, dear old Wickliffe, as in years gone by, resting on the highlands, nestling amid the oaks, on a Sunday in June, overlooking a country of unsurpassed beauty, with a rich promise of ripening fields of grain, that bend to the footsteps of the light winds, as they chase the flying shadows of the clouds, in your iron simplicity, a forerunner in those days, as John the Baptist in his. Your tottering structure long ago has been removed to give place to another; as those, who were at the time I speak, fathers and mothers of the flock, have gone to give place to their children, and to their children's children. In spite of the dull sound of a long sermon, you lie in the sunny memory of childhood as a sail in the offing, bothed in the glow of a summer morning. Christmas. 1879.
